Major decisions by the board of directors should always be formally documented in writing and added to the corporate record. The board approval choice is binary: either the board votes to approve a resolution at a board meeting with a quorum; or unanimous written consent is obtained from all directors eligible to vote, via a circulated proposed resolution.

Resolutions are written statements voted upon by the board members of a governmental group, non-profit or other agency. A group may approve a resolution honoring someone upon their retirement or simply to recognize a person's hard work on a project. The vote goes on the group's permanent record and is a formal method of showing appreciation.

1. "Resolved" should be in italics with a comma after it. 2. If the resolution is addressed to or refers to a specific group or groups, it must name in full (for example, American Library Association) the group or groups in both the "resolved.

Sample of Resolution Format

A resolution is a main motion that needs to be expressed formally in writing, to attach a special level of importance. Because of the form — beginning with the word Resolved and following with either a statement of opinion or a statement authorizing or directing some action — such a motion is called a resolution.

The author of a resolution is called a sponsor. Most resolutions have multiple sponsors because it takes a group of countries to share good ideas and to come to a consensus. Some conferences allow delegates to sponsor multiple resolutions for each topic while others only allow delegates to sponsor one per topic.

When writing your board resolution, remember to: Have the board resolution printed on company letterhead. Have the resolution signed by at least two directors of the company at a board meeting. Have your company seal added to the resolution. Using the example of a bank account, a company will need to pass a board resolution for each account that it plans to open.

Whenever your board proposes new rules, regulations or resolutions, it's a good idea to circulate the draft among your community's homeowners and provide an opportunity for feedback. Vote and sign. Once your feedback period ends, the board will vote on the resolution. The board president and secretary should then sign and date the document.
